**Directions to Show**

From North 1-75: At Gainesville exit on Highway 24 West (Archer Road) to Bronson. Go 19 miles, turn left at light on Alt. US 27, .4 miles turn right onto CR 337, Black Prong is 8.5 miles on right. From South 1-75: At Ocala exit turn left on US 27 north, go 7.2 miles and turn left on CR 464B West (Shell Station across on the right) Go 8.5 miles, turn right on US Highway 41 North and then at 2.5 miles turn left on CR 326 West. Follow for 8.5 miles and turn right on CR 337 North. Black Prong is 2.5 miles on the left.
