Please use 3141 Griffin Ave., Lady Lake, FL 32159 as your entrance.

From I-75 North: At Belleview Exit 341, Take Hwy 484 East to Hwy 441/27, turn right on Hwy 441/27 South. Turn left at CR 42 and continue to Weirsdale. Turn right on CR 25. Continue until you reach light at Griffin Ave. Turn left onto Griffin Ave. Follow Contestant signs to 3151 Griffin Ave. entrance. From I-75 South & Turnpike: At Wildwood Exit 329, take Hwy 44 East to SR 301 North. In Summerfield, turn right onto CR 42 to Weirsdale (cross over 441/27). Turn right on CR 25. Continue until you reach light at Griffin Ave. Turn left onto Griffin Ave. Follow Competitor Entrance signs to 3141 Griffin Ave. entrance.
